

# OXY-DATE 2

## ULTRA PEROXYGEN BLEACH

### For Industrial and Laundry Uses

This product is a high quality industrial cleaner, bleach and oxidizing supplement to sanitation and laundry operations. Add this product at the rate of 0.5-2 lbs per each 5 gallons of water. Warm water (100 F) may be used to dissolve this product, but is not absolutely necessary for the activation of the peroxygen ingredients. Hot water may not improve performance of this product. It is harmless to plastic and stainless steels and most other equipment, with the exception of "yellow" metals, such as brass and copper. After mixing the OXY-DATE 2/water blend, apply product and allow to work for 5-10 minutes and rinse with water. You may use this product undiluted by first wetting the surfaces and broadcasting this product.

This product is acceptable for use on food contact surfaces.

#### FIRST AID:

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing eye. Call poison control center or doctor for treatment advice, if necessary.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

**IF SWALLOWED:** Call poison control center or doctor for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

**IF INHALED:** Move person to fresh air.

#### STORAGE AND DISPOSAL:

**STORAGE:** Keep product dry in tightly closed original container when not in use. Store in a cool, dry, well-ventilated area. Product should be stored at 50° F or above.

**DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. DO NOT REUSE EMPTY CONTAINER. Triple rinse the container (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incinerate.
